- Collect data: utilize intakes, progress notes, IEP behavior data, and other assessments, to pinpoint wins, challenges, and growth.
- Develop and support student treatment plans and/or other individualized student plans (e.g., Behavior Support Plans; Crisis Plans; etc.).
- Work with staff to ensure a therapeutic milieu throughout the school/program.
- Collaborates with and learns alongside the school tribe.

- Review and update student treatment plans and/or other individualized student plans.
- Contact parents and families.
- Check-in with students.
- Observe students in numerous areas of the school.
- Participate in responsive and proactive circles.
